Introduction

The mission of the Post Polio Support Group is to create awareness and to provide information regarding the late effects of Polio among Polio Survivors, statutory agencies and the wider medical profession, and to ensure that the needs of Polio Survivors relating to their condition are met to enable them to live with dignity.

The Post Polio Support Group was established for Polio Survivors by Polio Survivors. The Group was formed in 1993 and is run by a voluntary Board of Polio Survivors and volunteers. It is supported by voluntary committees, active members and a small executive staff at the office in Dublin. PPSG is the only organisation in Ireland providing practical support to those unfortunate enough to have contracted Polio. The Group currently has 917 members across the country.

PPSG assists Polio Survivors by providing aids to daily living, stair lifts, callipers, bespoke footwear, electric scooters and wheelchairs. The Group also helps Survivors access Physiotherapy, Occupational Therapy and Respite Breaks, and it provides those who need it with assistance with their heating bills. The Group employs two Service & Information Co-ordinators who provide information, respond to requests for assistance from members and, perhaps most importantly, provide a listening ear to Survivors in need.

PPSG has a network of 22 social support groups around the country and also offers a telephone support service for those members who have difficulty in attending meetings.

The Group works tirelessly to:

- Create awareness of Post Polio Syndrome
- Provide information on Polio and its late effects
- Ensure the needs of Polio Survivors relating to their condition are met to enable them to live with dignity

Any of the estimated 7,000 Polio Survivors in Ireland can contact the Group for support irrespective of whether they are a member or not.

Funding for the Post Polio Support Group is provided by the Health Service Executive; Department of Environment, Community & Local Government; the Polio Fellowship of Ireland; The National Lottery and various grants from statutory and private bodies and fundraising by members, families and friends.

Chairperson's Report

I am pleased to say that last year was a more stable one in the life of the PPSG. This has been achieved by the dedication and hard work of so many people. Staff, Volunteers, Committees and the Board. The successful existence of an organisation such as ours relies on the various components coming together in a spirit of understanding and goodwill - no one component is of greater importance than any other. all make an equally valuable contribution.



Having said that, we continue to face a number of challenges. Firstly, how our Group is funded. We were able to secure funding from a number of sources last year, the main ones

being the HSE, Polio Fellowship of Ireland, the Department of Environment, Community and Local Government and our own fundraising efforts. In the case of the Rehab Group/Polio Fellowship of Ireland although they gave us a grant of "25,000 they also informed us that they would not be able to provide us with any funding in 2015. This clearly leaves a large hole in our income that we cannot replace. We will be raising our concerns regarding this development with the Rehab Group in 2015.

Last year, we applied for a grant from the Department of Environment, Community and Local Government under the Scheme to Support National Organisations (SSNO) in order to fund our two Development Officer positions. Along with a number of other smaller charities, we were turned down in June, just as the previous funding was about to run-out. In consultation with the Disability Federation of Ireland, we commenced a campaign to have the funding reinstated. Representatives of the PPSG attended a session in the Dail to demonstrate our outrage at the withdrawal of this funding. While the funding was reinstated for one year by the newly appointed Minister we were advised that a review of this grant system would take place. We hope this review will result in the continuation of the funding for disability organisations such as ourselves long-term.

Last year was quite a successful one for Fundraising. "76,000 was raised in respect of 2014 and another "25,000 for 2015. We were able to secure sponsorship of "10,000 for the Polio Day lunch in October which helped the event achieve a profit of "25,378. Fundraising is an important source of income for the Organisation and we are very grateful to those who have organised or carried out such activities for the Group. However, more initiatives are required in this area in order to compensate for the loss of income from statutory resources over the past five years.

Last year we examined every area of our expenditure to see where savings could be made. As a result, although our income in 2014 was down, so were our outgoings. The Accounts for the year show a surplus as opposed to a deficit in 2013 and, in that respect, our finances are in a much healthier state now. During 2014, Fran Brennan, our new CEO, restructured our accounting system to simplify our procedures and

enable us to meet the demands of those who require details of our financial affairs with accuracy and transparency.

At the beginning of this report, I mentioned that our organisation was in a more stable period. However, we cannot afford to be complacent. We must ensure that the Group is sustainable in the short to medium term and is fit for purpose to achieve this. Last autumn, we embarked on a process of creating a stronger, more vibrant and effective Group that would be capable of facing the challenges of the future. In order that the whole membership would have the opportunity to contribute to these discussions, we arranged a series of meetings around the country to which all members were invited. The feedback from these meetings will be taken up by the Social Support Committee and they will prepare recommendations on how to achieve this objective.

Over the next few years, we may also need to examine other aspects of the Group work in order to ensure that we have the appropriate structures, personnel, work practices and procedures to sustain this Organisation. The fact that the needs of Polio Survivors will increase in the short term is well documented and we must ensure that we have the wherewithal to provide appropriate supports. We also have to face increased demands from external sources such as the complexity of the Service Level Agreements we have with the HSE, the statutory functions of the Charities Regulatory Authority, the accounting procedures required by the Standard of Recommended Practice and so on. Change is not always easy but it is important that we are willing to adapt to the changing environment in which we operate in order to continue to meet the needs of Polio Survivors.

I am confident that, with the help of everyone concerned with the PPSG we can meet the challenges of the future and continue to serve the needs of Polio Survivors.

Annual Conference & AGM 2014

Nevertheless 184 members attended on the day which demonstrates just how important the conference is for many Post Polio members.







Some Highlights of 2014

CEO Changes

Afterwards, it was out to the marquee where members had drinks and entertainment and where the group admired one of the Presidents lovely Bernese mountain dogs, Shadow.

The entertainment was introduced by Master of Ceremonies on the day, Mr Ray DoArcy. Music was provided by the first lady of country, Margo, who had the guests clapping and tapping. After fifty years in show business, her voice was as wonderful as ever. Other entertainment was provided by Rackhouse Pilfer and We Banjo 3.

Later in the afternoon, guests were treated to a unique walkabout by President Higgins in the gardens of the Áras. Some guests had an individual photo with the president. The day ended with a tour of the formal rooms. Everyone agreed it had been a fantastic day out and the staff were very friendly.

Fundraising Activities

Several exciting and successful fundraising events took place in 2014. Among these was a mother and daughter sponsored climb of Kilimanjaro, a masquerade ball and a lunch for World Polio Day with comedians Colm OdRegan and Barry Murphy. Several volunteers took part in the 2014 LadiesqMini Marathon, and Dublin city and Cork marathons on behalf of PPSG also. Two extremely successful member draws also took place during the year.

In addition, many fundraising activities were undertaken locally nationwide by members and volunteers. These included church gate collections, fun runs and supermarket bag packs. Donations by members and businesses also made an important contribution to PPSG funds.

World Polio Day Lunch - A Hearth Warming Success



The Post Polio Support Group World Polio Day Lunch on Friday, 17th October was a tremendous success. With all the monies the final tally was an incredible "25,378!

Thanks to the success of the event, the PPSG was able to allocate the full heating grant of "125 to those members who needed it to get through the winter. All those who benefitted are very grateful for this much needed support.

Many of Irelands leading companies and business people supported the Lunch including Bord Gais, A & L Goodbody, CRH, NTR, Lagan Cement and Gaelectric. Guests from business sectors as diverse as media, horseracing, property, hospitality, technology and leisure attended.

Last year, for the first time, we secured an overall sponsor for the event. Davy Group contributed "10,000 towards the cost of hosting the event. This sponsorship catapulted the funds raised to a completely new level. We are very grateful to Davy Group for this invaluable support.

While the lunch was a serious fundraiser it was also a great afternoons entertainment. Irish Pictorial Weeklys Barry Murphy in the guise of renowned Bundesbank Economist, Dr. Günther Gruhn, hilariously took the guests to task for their extravagant ways. Barry

was joined by author and comedian Colm OdRegan. Colm had his audience in stitches with his descriptions of unique Irish personalities and behaviour that we all recognised.

Kilimanjaro Sponsored Trek

Mother and daughter team Anne and Francesca Hunt presented a cheque for €6,264 as a result of their very successful trek up Kilimanjaro to the Bray Post Polio Support Group at its meeting in the Glenview Hotel on 5th August.

During her presentation to the Group Francesca Hunt commented; "We are delighted to be able to support the Post Polio Support Group. We are keenly aware of the work this small organisation does in supporting Polio Survivors throughout Ireland. We hope this money will help in assisting the efforts of PPSG to allow Polio survivors live in their own homes, with dignity and independence, for as long as possible."



Service Provision

The Post Polio Support Group provides a range of services to Polio Survivors. These include information, support with aids and appliances, a variety of therapies, respite, stairlifts and heating grants. These supports are administered by a Service and Information Co-ordinator (SIC) and an Assistant SIC. The Post Polio Support Group would like to gratefully acknowledge the financial support of the HSE in particular, the Polio Fellowship of Ireland and a variety of other grant making trusts who make these services possible.

There are over 7,000 Polio Survivors in Ireland. In addition to the original physical disability from Polio around 60% of survivors may be experiencing Post Polio Syndrome which can occur many years after the original infection.

The membership of the Group currently stands at 917. In addition between 200 and 250 additional non-member Polio Survivors approach the Group for help from time to time. The Group does not distinguish between members and non-members when allocating supports.

Social Support

The PPSG runs 22 social support groups around the country in the following locations:

Athlone, Co Westmeath; Bray, Co Wicklow; Castleblayney, Co Monaghan; Carlow; Carrick on Shannon, Co Leitrim; Ennis, Co. Clare; Cork, Finglas, Swords, Clontarf and Tallaght in Dublin; Donegal; Enniscorthy, Co Wexford; Galway; Kilkenny; Limerick; Navan, Co Meath; Kildare; Castlebar, Co Mayo; Portlaoise, Co Laois; Sligo; and Kerry.

Telephone Support

Telephone support is provided both formally and informally from home to home by and for Polio Survivors across the Republic through our RingRing and PhoneChat services. 86 members availed of the RingRing service while 15 benefitted from the PhoneChat service in 2014.

A total of "37,916 was spent on social, telephone and other support in the year.

Aids & Appliances

63 people received Aids & Appliances during the course of the year. Total expenditure on Aids and Appliances was "97,730.

Therapies

82 people availed of services such as Physiotherapy, Occupational Therapy, Chiropody and Respite at a total cost of "22,080.

Winter Heating Grant

The Group provides a heating grant to those members who have difficulty in meeting their heating bills. In 2014 we helped over 300 members with a heating grant of "125"

each at a total cost of "36,000. All of the money spent on the winter heating grant is sourced through fundraising

Other Supports

Other supports provided to members include assistance towards meeting the cost of installing stairlifts and a hardship fund for those Polio Survivors in acute need.

Complaints

The Group has a complaints procedure and the Company Secretary maintains a register of all complaints and actions arising. There were no complaints registered in 2014.
