

Introduction

The mission of Polio Survivors Ireland is to create awareness and to provide information regarding the Late Effects of Polio among polio survivors, statutory agencies, the wider medical profession, and to ensure that the needs of polio survivors relating to their condition are met to enable them to live with dignity.



Polio Survivors Ireland was established for polio survivors by polio survivors. The organisation was formed in 1993 and is run by a voluntary Board of polio survivors and volunteers. We are supported by voluntary committees, active members and a small executive staff at the office in Dublin. Our organisation is the only one in Ireland providing practical support to those unfortunate enough to have contracted polio. At the end of 2019 we had 975 members across the country.

Polio Survivors Ireland assists polio survivors by providing aids to daily living such as stair lifts, callipers, bespoke footwear, electric scooters and wheel-chairs. We also help survivors access Physiotherapy, Occupational Therapy, Respite Breaks, and provide those who need it with assistance with their heating bills. We employ two Service and Information Co-ordinators who provide information, respond to requests for assistance from members and, perhaps most importantly, provide a listening ear to survivors in need.

The organisation has a network of 20 Social Support Groups around the country and also offers a Telephone Support Service for those members who have difficulty in attending meetings.

We work tirelessly to:

- · Create awareness of Post Polio Syndrome
- · Provide information on Polio and its late effects
- · Ensure the needs of polio survivors relating to their condition are met to enable them to live with dignity

Any of the estimated 7,000 polio survivors in Ireland can contact us for support irrespective of whether they are a member or not.

Funding for Polio Survivors Ireland is provided by the Health Service Executive, the National Lottery and various grants from statutory and private bodies and fundraising by members, families and friends.

Chairperson's Report

Financially 2019 was a difficult one for Polio Survivors Ireland. The reality is that no organisation can continue to operate for 12 years with reduced funding and no prospect of any restoration of funds. Our loss for the year is just over €9,000 which in the circumstances is an achievement. However voluntary organisations cannot be expected to continue to provide the same level of services and supports indefinitely without additional funding. In our case the HSE cut our funding by €80,000 a decade ago. It is notable that since the last recession the HSE has had all the funding that was taken from it restored by the Government but it has not handed back any of this restored funding to the organisations that it took it from. To add insult to injury the HSE wants to implement a further 1% cut on voluntary organisations in 2020. It is clear that there is an urgent need to re-establish a constructive relationship between the Dept. of Heath, the HSE and the voluntary organisations like ourselves who provide much needed and valuable health and disability services and supports to the community.

Despite this difficult backdrop our organisation has continued to meet the needs of people living with the effects of polio. 291 people contacted us for help and hundreds others benefitted from our Social Support and Telephone Support Services. In addition we provide useful information to our members through our Survivor Magazine, our regular ezines and our annual conference which was held in Charleville. One way or another all of our almost 1,000 members have benefitted from Polio Survivors Ireland in the past year.

2019 was also a year of on-going change and development within the organisation. Three new Board Nominated Directors, Elaine Twomey, Fintan Foy and Miriam Kavanagh were ratified by the AGM. We also commenced our new Area Meetings of members and prospective

members with meetings in the autumn in Dungarvan and Enniscorthy. These meetings have been very well attended with between 20 and 25 people present at each event.



Last year also saw continued success in our Polio Register campaign. 20,000 leaflets were distributed through GP's practices, hospital emergency departments and primary care centres. This was supported by national advertising on RTE Radio and newspapers such as the Irish Independent, Irish Examiner, Sunday World and the Daily Star. Regional promotional campaigns were also conducted in the South East, South Midlands and Kildare. This promotional activity led to 97 polio survivors signing up to the Polio Register. Our membership has also continued to grow with 75 new members recruited in 2019. 10 new active members were appointed to roles within the organisation and a further 7 external volunteers were also recruited.

I would like to thank my colleagues on the Board for their unstinting efforts on behalf of the organisation and its members. The new Board members in particular have brought a wealth of skills and experience as well as a fresh perspective to our Board which proved very valuable during the course of the year.

I would also like to highlight the hard work and dedication of the staff team and all the active members and volunteers. The work of the organisation and its services and supports to polio survivors very much depends on their efforts. On behalf of the Board and indeed the members of the organisation I would like to thank them.

Despite the many challenges that confront the organisation we will continue to make a major difference to the lives of polio survivors.

Report on Annual Conference and AGM

Our 2019 Conference took place in the Charleville Park Hotel, Co. Cork on 30th May and was well attended by members from all around the country. We were delighted to welcome so many familiar faces and to see some new ones also. The Conference is always a wonderful opportunity for members and friends to meet and catch up, providing that invaluable support and social aspect to being a polio survivor.

At this year's Conference our guest speakers were Deirdre Ryan, from Chronic Pain Ireland and Dr Meredith Raley, from the Disability Federation of Ireland. Deirdre discussed how chronic pain can deeply impact the quality of life of an individual, but by pacing yourself and finding the perfect balance of moderate exercise and relaxation, you can live comfortably and with peace of mind. She suggested making a schedule to follow during the week and working around it to help feel your absolute best.

Meredith led her presentation about the human rights treaty the Convention on the Rights of Persons with Disabilities (UNCRPD). It was signed in 2007 and was ratified in Ireland in spring 2018. She spoke about how the implementation process has already begun and how one may build awareness for the UNCRPD, for example, by reminding policymakers or including it in official literature. Our member, Mick Keegan reminded attendees during the Q&A, that the Treaty gives them the right to ask businesses to make changes to improve accessibility.

Chairperson Pat McGillion gave a presentation on implementation of the organisation's strategic plans board developments that are in progress. Treasurer Macrina Clancy presented the annual income report for 2018.

Roisin Nolan retired as a director after many years hard work on behalf of the organisation. Robert Alcorn, Macrina Clancy and Frank Mitchell were elected to the Board unopposed and the Chair welcomed the new Directors to the Board.







Location


Forty (55%) respondents rated the location as Very Good, 20 said it was Good, while 12 regarded it as only Average. One (1) did not submit any opinion on the location.

This question received the third highest number of comments, nineteen (19). While the overall rating for the location was "very good," people were divided on where the next location should be. All biased towards their specific towns.

Talk by Deirdre Ryan of Chronic Pain Ireland


As can be seen from the above chart forty six (63%) respondents rated the Deirdre Ryan lecture as Very Good, 21 said it was Good, 3 said it was Average, 2 said it was poor while 1 person did not form any opinion. Combining the "Very Good and Good" responses together equates to a satisfaction rating for this session of approximately 92%.





Presentation on UNCRPD by Meredith Raley


Twenty four (33%) respondents rated the presentation by Meredith Raley as Very Good, 22 said it was Good, 6 said it was Average, 2 said it was Poor, while 3 said it was Very Poor. Sixteen (16) respondents did not submit any opinion. The satisfaction rating for the presentation is approximately 63%.



AGM

Forty four (60%) respondents rated the AGM as Very Good, 20 rated it as Good, 3 rated it as Average, 1 rated it as Poor, while 1 rated it Very Poor. Four (4) respondents did not submit an opinion.

The number of comments submitted in answer to this session was average to below average with (11%). The consensus was that the AGM was well received and enjoyed by most.



Rating of the Conference Overall

Forty two (42 – 28%) respondents rated the event as Very Good, 23 said it was Good, while 3 regarded it as only Average. Five people (5) did not submit any opinion on the event overall.

Make Way Day Campaign

Highlights of 2019

World Polio Day

For World Polio Day on 24th October, the organisation highlighted the very limited availability of physiotherapy from the Health Service in the community. A survey of our members revealed that a majority of polio survivors with a medical card cannot access enough physio to meet their needs. For those without a medical card, as many as 70% cannot afford to pay for the physiotherapy that they require to maintain their independence, manage pain and minimise falls.



Cold Study at Trinity College Dublin

Members of Polio Survivors Ireland who suffer with an intolerance to cold took part in a research study at Trinity College Dublin. The study was conducted as part of a PhD within the School of Computer Science and Statistics, TCD, in collaboration with the Division of Media Technology and Interaction Design of KTH Royal Institute of Technology, Stockholm. People with health conditions who suffer from cold intolerance were sought, including polio survivors. One of our members, Zaynab Salman, was involved in organising the workshops as part of the research team. The goal was to understand how participants are impacted by cold intolerance, how they cope with it and their opinion on potential new technologies. The collected data will inform the design of technologies that could help with extreme sensitivity to cold. The study also looked at how people respond to interactive technologies placed close to their body, for example wearable heatgenerating components such as electric heating pads and Peltier elements (heat pumps which transfer heat from one side of the body to the other). The resulting prototypes will be aimed at providing specifications for a real workable system, rather than a theoretical one.



Northern Ireland Polio Fellowship (NIPF)

Susan Dowling was delighted to receive an invitation to the NIPF 80th Anniversary Celebrations at the Stormont Hotel, Belfast, on 11th May 2019. Susan was asked to the dinner on behalf of Polio Survivors Ireland to celebrate this wonderful achievement. They had previously attended one of the Northern Ireland Polio Fellowship conferences and, once again, they made them very welcome.

Cork Social Support Group



Saturday 28th September 2019 may have been a rainy day in Cork, but it was all very relaxed in the Ennismore Centre where the Cork Social Support Group hosted their Chill Out Day.

With 34 in attendance, the day started with Convenor Eileen O'Mahony introducing the day's speakers, Fran Brennan (CEO) and Maria Ham (Physical Instructor). Fran spoke of the changes in the organisation since 2003, including HSE funding cuts, drops in donations, the unresolved situation between the Polio Fellowship/Rehab Group and polio survivors. Fran also informed the meeting that over 300 people had signed the Polio Register.

Maria put everyone through their paces, both physically and mentally, demonstrating activator poles that have been adapted from Nordic walking sticks and exercises that could be completed while seated and that support coordination. Members participated in an amusing quiz and finally, some quiet contemplative time. It was an enjoyable and relaxing day with plenty of time to catch up with old friend and make some new ones.


Cork Mini Marathon 2019



Service Provision 2019

There were 975 members of Polio Survivors Ireland at the end of 2019. Polio Survivors Ireland provides a range of services and supports to polio survivors. These include information, advice, personal advocacy, funding for aids and appliances, a variety of therapies, respite breaks and stairlifts as well as heating grants. These supports are administered by the Service and Information Co-ordinator (SIC) and the Assistant SIC. Polio Survivors Ireland would like to gratefully acknowledge the financial support of the HSE in particular, a number of other grant making trusts and of course our fundraisers without whom these services and supports to our members could not be provided.

Generally these supports commence with the SIC or ASIC who work with HSE staff and other professionals to provide services and supports appropriate to the individual polio survivor. 291 polio survivors sought help in 2019. In addition, the organisation provides social support through its network of social support groups around the country and operates a peer led telephone support service. The chart below illustrates the breakdown of service and support provision in the year.



- · 89 members received information, advice or personal advocacy in 2019
- 55 members benefitted from the provision of aids, appliances and stair lifts in the year
- 93 members received physiotherapy, occupational therapy, chiropody, counselling or respite
- · 249 members were supported by a Winter Heating Grant
- · Approx. 190 members attended a social support meeting or activity
- · 33 members were receiving regular calls from the Telephone Support Service

The Survivor Magazine

This magazine is sent out to all members three times a year. It contains useful information on polio along with articles on other health and wellbeing issues and the work and activities of the organisation. The cost of the magazine in the year was just over €8,000.

Annual Conference

The annual conference through its guest speakers and stands provides a useful service to those members who attend. The 2019 conference had speakers on managing pain, the UNCRPD and the Polio Register as well as a number of informative stands.

Complaints


Polio Survivors Ireland has a complaints procedure and maintains a register of all complaints and actions arising. The organisation received no complaints in 2019.



Financial Report 2019

The accounts for 2019 record a loss of €9,165 for the year. This compares to a loss of €2,404 in 2018 reflecting how difficult it has become to maintain services while operating on greatly reduced funding compared to a decade ago.

Income




The HSE accounts for 80% of income received in the year. Almost 3/4 of this funding is from Community Health Organisation (CHO) region 9 which funds all of Polio Survivors Ireland's staff as well as much of its organisational and administrative costs in addition to services and supports to members in North Dublin. The next largest funding region is CHO 4 (Cork & Kerry) which provided over €40,000 in funding in 2019. A further 5 HSE CHO Regions provided funding of between €6,000 and €14,000 last year to provide services and supports to polio survivors in their regions.

General Fundraising income includes donations and fundraising activities by

members along with legacies and collections. Fundraising and other grants are very important as it enables us to offer supports to members which are not met by the HSE funds such as the winter heating grant.

Members Contributions are membership fees paid by members and contributions by members towards the costs of running social support activities. The Old Bequest is a large legacy received by the organisation some years ago a portion of which is drawn down each year to supplement current income.

Expenditure




Total expenditure in 2019 was € 464,682. The chart above outlines expenditure by category of expenditure.

Organisational Costs




These are costs associated with running a national organisation and its governance. The two largest areas of expenditure in 2019 were Promotion & Education, which was primarily the costs incurred in promoting the Polio Register, and the Annual Conference/AGM.

Administration Costs

Administration staff account for the largest proportion of administration costs. These costs cover the cost of the CEO, Development Officer and the Administration Officer. None of the salaries exceed € 60,000 p.a. General Administration costs include rent, insurance, stationery, accounting and audit, telephones and heating and lighting.

Reserves

Net Current assets less current liabilities at 31st December 2019 were € 114,852 compared to € 125,142 at the end of 2018.



Outlook

These are very challenging times for the charity sector especially as there is no indication that the HSE intends to restore the funding it took from charities during the last recession. The board however is confident that the organisation can continue to provide a good quality service provided there is no further diminution of our revenue. The deficits of recent years shows that funding in the years ahead will be a matter of concern and other funding streams will be crucial. This will be very difficult for Polio Survivors Ireland.

Directors Report

The directors present their report and the audited financial statements for the year ended 31 December 2019.

Principal Activity and Review of the Business

To create awareness and to provide information regarding the late effects of polio among Polio Survivors, statutory agencies and the wider medical profession, and to ensure that the needs of Polio Survivors relating to their condition are met to enable them to live with dignity.

The Company is a registered charity with the Charities Regulator (20030926) and with the Revenue Commissioners (CHY 11356). The Company is limited by guarantee not having a share capital. There has been no significant change in these activities during the year ended 31 December 2019.

Principal Risks and Uncertainties

Financial risk management objectives and policies: The company uses financial instruments throughout its business. The core risks associated with the company's financial instruments are set out below. The board reviews and agrees policies for the prudent management of these risks as follows.

Liquidity and cash risk: The company's policy is to ensure that sufficient resources are available either from cash balances or cash flows to ensure all obligations can be met when they fall due.

Credit risk: The company's credit risk is dependent on the debtors' ability to pay within the company credit terms.

Financial Results

The deficit for the financial year after providing for depreciation amounted to (€9,165) (2018 - (€2,404)).

At the end of the financial year, the company has assets of €171,666 (2018 - €225,934) and liabilities of €56,814 (2018 - €100,792). The net assets of the company have decreased by € (10,290).

Directors and Secretary

The directors who served throughout the year are noted on page 2. There were no changes in shareholdings between 31 December 2019 and the date of signing the financial statements. In accordance with the Constitution, the elected directors but not the Board nominated directors retire by rotation.

Future Developments

While the Organisation is committed to reaching out to all Polio Survivors in Ireland, the welfare of its members remains its paramount concern. The Organisation is committed to ensuring that, as far as possible, sufficient funding is found to ease their problems and increase quality of life.

The Organisation will remain committed to maintaining sufficient income to meet the needs of Polio Survivors in real terms. Close liaison with the various Statutory Authorities, principally the Health Service Executive (HSE), will continue to be maintained and the Organisation will work in close partnership with all its funding bodies to accomplish its objectives.

NOTES TO THE FINANCIAL STATEMENTS for the year ended 31 December 2019

1. GENERAL INFORMATION

The Post Polio Support Group is a company limited by guarantee incorporated in the Republic of Ireland

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements. Statement of compliance

The financial statements of the company for the year ended 31 December 2019 have been prepared on the going concern basis and in accordance with generally accepted accounting principles in Ireland and Irish statute comprising the Companies Act 2014 and in accordance with the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland (FRS 102) issued by the Financial Reporting Council

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council. The company qualifies as a large company as defined by section 280H of the Companies Act 2014 in respect of the financial year. Income

Deferred Income: Bequests and donations, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance. Where income is received in advance, recognition is deferred and, being only recognised in the period profit and loss account against matching expenditures. Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible fixed assets, less their estimated residual value, over their expected useful lives as follows:

Computer equipment - 25% Straight line Fixtures, fittings and equipment - 15% Straight line

The carrying values of tangible fixed assets are reviewed annually for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable.

Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Post Polio Support Group (A company limited by guarantee, without a share capital)

Employee benefits

The company facilitates employee payments to a Personal Retirement Savings Account (PRSA), deducted at source, and makes agreed matching employer contributions. Access to a PRSA is available to all employees of the company.

Taxation and deferred taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable income for the year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more tax in the future, or a right to pay less tax in the future. Timing differences are temporary differences between the company's taxable income and its results as stated in the financial statements. Deferred tax is measured on an undiscounted basis at the tax rates that are anticipated to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined.
